Subject:- Grant of recognition to the school from class I to VIII (Without aid) w.e.f. academic session 1988-89 for a day school.

Sir,

With reference to your application on the subject noted above, I am directed to grant recognition to your school from class Ist to VIII (without aid) w.e.f. 1988-89 session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act and Rules, 1973 framed thereunder as well as the students issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of Tilak Nagar area.
3. That the school shall appoint full time qualified and eligible for all the classes of the school as per the present norms of the department and unqualified staff shall be replaced.
4. That the school shall equip the science lab. as per the norms of the department and suitable facilities for practical work shall be provided to the students. More materials worth Rs.5000/- shall be purchased in March, 1988 and a list be furnished to E.O. for verification.
5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added and facilities of reading room may also be provided immediately and more books worth Rs.500/- may be purchased by the start of next session in March, 1988 and the list of books be furnished to EO for verification.
6. That adequate sports materials shall be purchased and made available to the students immediately.
7. That the school shall strictly abide by the provisions of Delhi School Edn. Act & Rules, 1973 and payment shall be made as per sec.10(i) of DSEA, 1973 and to all employees.
8. That the enrolment in each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education Delhi in each class. Number of the existing sections should not exceed the number of the class room of similar size in the school.

9. That the school/society shall obtain land from the DDA for the unaided school and shall shift its classes to the new site with the permission of DE.
10. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
11. That the service contract between the management and the employees shall be executed immediately.
12. That all the facilities prescribed under Rules 50 and 51 of the DSER, 1973 shall be made available to the students. Provisions of Rules 6, 7 and 9 be strictly observed.
13. That the arrangement good drinking water shall be made available too all the students as well as to the teachers. and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the Local Body within a month.
14. That the management of the school shall create a Reserve Fund of Rs.5000/- (Rupees five thousand) only in a joint account in the name of the Director of Education and the Manager of the school in any scheduled bank within a month.
15. That the violation of any instructions/orders/conditions rules and regulations of the department shall lead to the withdrawal of recognition of the school and class IX shall not be opened without the prior approval of the Director of Education, Delhi.
16. That a report about the fulfillment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer every six month.
17. That the management of the school shall surrender its recognition from class 1st to Vth MC, immediately as composite recognition has been accorded by Inspector of Education, Delhi.

That the service contract between the management and the employees shall be executed immediately.

Fresh Health Certificate from MCD be obtained and produced E.O. for verification.

That the Management Committee shall regulate the functioning school strictly in accordance with the provisions of DSEA and R.R.s, 1973.

That the Managing Committee of the School shall not release fee in future academic sessions without prior approval the Director of Education, Delhi which is a mandatory requirement under sub-section(3) of Section-17 of DSEA, 1973.

That all the facilities prescribed under rule 50 & 51 of DSER, 1973 shall be made available to the students.

Proof to the effect that qualified staff has been appointed per R.R.s be provided for verification to E.O.

That the staff has been paid all arrear and being paid as Fourth Pay Commission. Proof be given to E.O. for verification.

That all arrangements for good drinking water shall be made available to all the students as well as to the teachers. Sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the locality within a month.

That the school shall comply with the norms of the CBSE affiliation for examination purposes.

Medical facilities/leave, LTC, bonus, Teaching allowance, etc. be paid since recognition of school.

Provident Fund register be maintained and each book completed and shown to E.O. of the Zone concerned for verification in time to time.

That the violation of any instructions/conditions/norms and regulations of the Deptt. shall lead to the withdrawal/recognition/upgradation of the school.
